Big Sir Message: Thanks to Mike Egbert the President of the Chico Chamber, our



September speaker on the activities that they provide to improve the downtown experience for the Chico community. He was recruited out of retirement by local businessmen to bring the Chico Chamber of Commerce back to life after Covid. With his background in growing businesses, it seemed a perfect fit to bring a fresh new direction for the long vacant advocate for the local businesses. Mike left his own research consulting firm that was instrumental in shaping the landscape of Radio broadcasting stations across the United States and Canada using his expertise in consumer research and planning. He indicated he had done a lot of work in Chico in the past with his consulting business and that

moving here to help the local businesses he felt it was a perfect fit. One of the first projects was to clean up the downtown experience. He said that working with the downtown ambassadors, property owners, local tenants, and the University his goal is to make our downtown experience to feel safe and comfortable. One of his first projects is that all downtown vacant store fronts (23) have some form of art that has local flair, so it reflects a positive image. He also indicated that he has been a regular attendee at the City Council meetings, become a participant in most all the local boards and focus groups. He also indicated that the very unpopular parking meters are here to stay. He has

requested that local business operators and employees help the folks that struggle in the new meter experience whenever they can. I feel we all enjoyed his talk as there were a lot of great questions. He indicated that he works hand in hand with the Downtown Chico Business Association (DCBA). They both work to clean up and improve the downtown businesses. In my mind, they should combine forces in the near future.

This month we were scheduled to have the current President of Chico State, Dr. Steve Perez, as the October speaker. Unfortunately, a conflict with a state meeting developed and he is unavailable. State SIR Meeting Report

Gentleman: Don Sturt, Chip Merriam (Branch 84) and I went down to the State meeting in Lafayette on Tuesday September 24th. We were introduced to the new SIR State President Rich Carlston. He has a fabulous resume as 30+ years as a Real Estate litigator for the Federal Real Estate Group and the National Association of Realtors. He spoke to us about how many hours that the State officers spend on SIR. He indicated that most of them work full time as much as 50 hours a week for a non-paid position to keep this group functioning like it does. He said that 1/3 of the branches are in steep decline, 1/3 are just staying the same, and the last 1/3 are growing at a 10% growth rate a year. He indicated that they have an annual budget of almost \$80,000 and the expenses last year were about \$77,000 so there is a 2-3% at most carryover. One of the big problems he said we always have had is the Insurance costs. If we drop many more members the Insurance may be much more expensive. That doesn't appear to be a big problem from the Insurance guy in his speech. He indicated if the Insurance Company continues to do business in CALIFORNIA, we will be OK. (FYI in the long history of SIR there have been only 2 claims against the Insurance Company. One was a very frivolous charge but the second was a guest died from eating a bad piece of Corned Beef at a St. Patricks's Day lunch. He indicated the guy got out of his death bed to come to the event but nevertheless he died after lunch)

Rich Carlston indicated that the two main problems in SIR are **MEMBERSHIP** and **LEADERSHIP**. That is exactly our problem in Branch 110. When he started to talk about the States solutions, I fully expected to be in the cross hairs of State folks' bitter feelings, if not just pure distain, to the 110 and 84 branches for our recent letters in opposition of their ideas. I personally felt that our recent negative input to most all the States vision of the future SIR was going to be front and center. I again thought that by being in direct conflict on the State's direction, we were going to have to defend our position all day long. We had no idea to what degree their plan going forward would contrast with ours. During the introduction of all our membership problems and the drastic decline of SIR members and branches since COVID, the State folks did a great job with statistics graphs and personal speeches. They were well prepared to visually explain the situation in the SIR world. Actually, we now have about 6,400 members statewide and in the big picture that is down over 40% in the last 4 or 5 years or so. There is a problem, as we all are aware. One solution is our plan is in opposition to the State's plan. They did, in the narrative of the problem, mention SIR Branch 110 as to their plan and ours.

The big surprise was that our opposition was successful. We learned that our emails had been received and were taken seriously. All of the questions from the floor referenced the future and solutions rather than the State's. One member indicated women were welcomed in their branch but I figured that he lived in a Senior Living Association. We were presently surprised that there was **NO VOTE** or much talk at all about their plan (this year). We did get a speaker talking about the proposed charge to a 501c 3 but this is only a 1-year moratorium. They created a WHITE PAPER and are creating a subcommittee to create a "SIR BRANCH ADVISORY COUNCIL". This advisory council will be comprised of branch leaders, it will be charged with helping the SIR Board of Directors establish the strategic direction and develop the implementation of plans to sustain SIR. This is a one-year delay only. We need to stay focused on this to not be forced into these drastic changes. In the O and A time, most of the questions pertained to the two hot topic's Women joining and the change in the tax status. They did say that they missed out on some donations recently because of the write-off provisions in the two. In the questions it sounded most everyone there was not in favor of opening it up to women except in a few branches it made sense. Rich Carlston did say that they did need to get some further legal opinions on some of these proposed changes. Most of the questions were in favor of our positions. They were asked just who will vote on any changes in the future. They were asked if it was the membership, the BEC's or just the State folks will determine the future, and the answer that I heard wasn't clear (maybe on purposes). They then went over the difficulty getting feedback from the individual branches and individual members. Kind of vague but Rich said that they didn't have a complete list of all members. (They are almost 1,550 short of emails addresses of the general membership. We are very fortunate in the work that Rocky does for our club. I bet we're in the top 2% of the State SIRs reporting). He kind of glossed over the BEC but I can't believe that they can make these changes without input from the BEC's. In summation: We were amazed at all the OLD GUY'S that showed up on Tuesday!!

We have one year and the clock is ticking. *Dave*
